# PLANT OPERTIONS

### Solids Holding Tank & Splitter Box Refurbishment Project

Plant Manager Arnold reported Precision Industrial Maintenance completed refurbishment of the Solids Holding Tank and associated splitter box, including sandblasting, hydro-cleaning, epoxy coating, and installation of new grating. Operators returned all equipment to service. Manager Arnold noted the Digester remained at full operation during the project.

### Authorize Chemical Bidding - Dry Polymer, Emulsion Polymer, & Sodium Hypochlorite

Plant Manager Arnold requested Board approval to seek bids for two (2) year contracts to be awarded at the December meeting for Dry Polymer, Emulsion Polymer, and Sodium Hypochlorite. On a motion made by Mr. Siarkowski, seconded by Mr. Hayner, carried five (5) in favor, one (1) absent, and none (0) opposed, the Board authorized advertisement for bids for two (2) year contracts for Dy Polymer, Emulsion Polymer, and Sodium Hypochlorite.

### **Contract Renewals**

Plant Manager Arnold reviewed rates and terms of the following contracts coming due at year-end:

- Leachate/Sludge Disposal Agreement between Fulton County Department of Solid Waste and GJJWTF,
- o Municipal Sludge from Fonda-Fultonville, Mayfield, Montgomery County, St. Johnsville, and Waterford,
- o Septic and Industrial Waste from Precision Industrial Maintenance,
- o Legal Services w/ Miller, Mannix, Schachner & Hafner LLC.

The Board agreed rates and terms would remain unchanged for the upcoming contract renewals.

# Sewer Bill Protest: 234 Kingsboro Avenue, Gloversville

Senior Account Clerk Rackmyre reviewed a request for sewer bill adjustment for excess water usage for property located at 234 Kingsboro Avenue in Gloversville. Plant Manager Arnold conducted an inspection of the premises. On a motion made by Mr. Siarkowski, seconded by Mr. Vose, carried five (5) in favor, one (1) absent, and none (0) opposed, the Board approved a credit of \$52.42 since the water did not enter the sewer system to be treated.
